

The regular monthly meeting of the Town of Cary Board was called to order at 6:00 PM on March 8, 2022.

Present were Board members: Mark Gosh, Chair; Dale Zawislan Supervisor; Dennis Brunner, Supervisor; Carey Rucker, Treasurer; and Jean Gansch, Clerk. Also present were two town residents.

Checks were reviewed and signed

Received from local businesses were donations for the upcoming WTA Unit meeting in the amounts of \$100 from Iggy's Trucking, and \$100 from OMG-Lee McDonald (meat processing plant).

Minutes from February 8<sup>th</sup> Board Meeting were read and motion made by Dale Zawislan to accept the minutes as read, and seconded by Dennis Brunner, motion passed.

Carey Rucker-Treasurer gave the Treasurer's report for January and February. Motion to file Treasurer's Report was made by Dennis Brunner and Seconded by Dale Zawislan, motion passed.

Discussion of the upcoming WTA Unit Meeting was held, updates on the donations, catering, and set-up of the hall.

Discussion on sprucing up the town hall, some maintenance concerns, both interior and exterior, were discussed. The Board will conduct an inspection of the hall at the time of the Spring Road inspection. Further action was tabled until April meeting.

Special notice of the website address for the township will be placed in the Pittsville Record with the next agenda.

Annual Meeting Date set for April 12, 2022 at 6:00 PM with the regular Monthly Board Meeting to follow.

Open Book and Board of Review were discussed. Our Assessor-Jerry Wegner-is in poor health (currently in rehab facility in Wisconsin Rapids-Eden brook), therefore these Meetings may be postponed.

The bridge on Steffic Road will need attention soon.

Road inspection will take place at the end of April or beginning of May.

TRIP grant was approved-90/10 for Johnson Road. The road will be black-topped and widened.

Mark will attend Town of Rock's board meeting to observe their procedures for taking road bids.

There is a balance of \$9318.67 that Wood County is holding that is a 50/50 match for future road projects that are yet to be determined.

Road Report—(Tim) Sparks Road by Jean Strack's place needs to have the dip filled in. Note from Frank Neve about ditching on Lindsey Road. Tim plans on disking the roads to recover lost gravel this spring. The bridge on Cary Rock Road has too much gravel.

New Business—Bug-Tussle is leasing land from Lee Accola to erect satellite dish tower. Mark inspected the site and discussed the need for a culvert, the decision was that none is needed. They will get a building/zoning permit from the town and are responsible for other building and inspections.

Contingency Plans for Clerk and/or Treasurer deputy appointments was discussed.

Problems with garbage pick-up were mentioned.

Clerk will look into ordering a "Chairman's Manual".

Motion to adjourn was made by Dennis Brunner and Seconded by Dale Zawislan, motion passed.
