Town Board Meeting—April 18, 2023

The regular monthly meeting of the Cary Town Board was called to order at 7:35 P.M. following the Annual Meeting of the Town of Cary. Present were Chairman Mark Gosh, Supervisors Dennis Brunner and Dale Zawislan, Clerk Jean Gansch and Deputy Clerk Lori Hiebl. The Pledge of Allegiance was recited, and a prayer was given.

The minutes of the March, 2023 Town Board Meeting were read, a motion to accept the minutes as read was made by Dennis Brunner and seconded by Dale Zawislan, motion passed.

Discussion was held on how to encourage people to attend the upcoming Rummage Sale to be held at the Town Hall to benefit the Hannah Center, sponsored by Jeff Ignatowski.
