The regular meeting of the Cary Town Board was called to order at 6:00 p.m. on June 10, 2025. Present were the board members: Mark Gosh, Dennis Brunner, Dale Zawislan, Carey Rucker, and Jean Gansch. Also present were two members of the community. The Pledge of Allegiance was recited and a prayer was given.

Checks were reviewed and signed. Minutes of the May13, 2025 meeting were read and a motion to approve them was made by Dennis Brunner, seconded by Dale Zawislan, motion carried.

Clerk reported that we received a Thank you note from the Pittsville Historical Society for our donation of \$200. Clerk asked that the air conditioner be installed by Saturday, June 14th for a hall rental. Clerk brought up the purchase of a new furnace for discussion—Chair asked Dennis to investigate prices and get back to the board for next month.

The Treasurer's report was presented and a motion to file report was made by Dale Zawislan, seconded by Dennis Brunner, motion carried.

Board will look into doing a referendum for a Levy Limit increase to keep our budget as it has been in past years.

Old Business: Open Book and Board of Review report—Several community members came to the Open Book session to discuss their assessments. There were no hearings for the Board of Review. The Assessor's Contract was presented to the board for approval, Motion to accept the new contract with Assessor Jerry Wegner for another year, with an increase of \$400 was made by Dennis Brunner, seconded by Dale Zawislan, motion carried. Motion to approve renewal of Class A Liquor License was made by Dale Zawislan, seconded by Dennis Brunner, motion carried.

Road Report: Dale Zawislan and Mark Gosh flagged the roads prior to gravel being delivered. Someone removed some of the flags that were place. 153 loads of crushed granite will be delivered to roads that need gravel, if township has leftover funds further graveling of other roads will be considered. Grav24.el will be delivered beginning on Cary Rock Lane and Flugstad Road with the rest to be continued the week of June 23-24.

Mark Gosh discussed using a sealant for blacktopped roads, he is checking out results before using this product. There is a suggestion to use chip seal on Steffek Road some time in the future. Bridge aid 50/50 with the county for the bridges on Steffek Road.

Public Input: There have website oversites that need to be looked into. Clerk will check the postings and notices more closely in the future.
