Minutes of the TBM
September 9, 2025

The regular monthly meeting of the Cary Town Board was called to order at 6:00 p.m. on September 9, 2025. The Pledge of Allegiance was recited, and a prayer was given. Present were board members: Mark Gosh, Dennis Brunner, Dale Zawislan, Jean Gansch, and Lori Hiebl; also present were two members of the community.

Checks were reviewed and signed. Some issues pertaining to checks were discussed, and one citizen mentioned the absence of the Superintendent of equipment, buildings, and roads.

Minutes of the August 12th, 2025 meeting were read, a correction/addition to the minutes was made to include the discussion of getting an AED for the town hall. Mention was made that possible grants may be available to get the device.

Clerk's Report: WTA workshop on September 15th, 2025 reminder, attending will be Mark Gosh, Dale Zawislan, Jean Gansch and Carey Rucker (if health permits). Wood County is having an Ag & Household Hazardous Waste Disposal on Saturday, September 13th at the Saratoga Town Hall—8:00-12:00. LP and Diesel delivery slips—where is a convenient place for the delivery driver to leave them? Suggested that we tell them to put them in the yellow posting sign box. Voting machines will be picked up by Lori and Jean on Wednesday, September 10, 2025 from the Courthouse in the Rapids.

Treasurer's report was skipped due to Treasurer's absence because of illness.

Public Input—Dust control was spread on Yetter Road, Mr. Gansch was appreciative. Someone spotted some oil running out of the shop. Is Tim still mowing ditches? Clerk received a call about WM missing garbage pickup on Flugstad Lane. Dennis will talk to Tim Miller at WM about this.

New Business—Budget Meeting is set for September 23rd at 6:00 p.m. Recycling meeting is rescheduled for September 16th at the Wood Town Hall 6:00 p.m. Cary Town Hall Ramp/Porch upkeep—Mark received a bid from Mike Coon to "prepare the visible wood surfaces (steps, decking, handrails, spindles, and supports) located on the south and east entrances to the town hall building. Application of two coats of Cabot brand semi-transparent exterior stain on same. Preparation of two entry doors (exterior surfaces) and application of one coat exterior semi-gloss paint of same. All materials and labor to be performed for the sum of \$1320.00. Payment to be made in full within 14 days of completion." Mike Coon. Motion to hire Mike Coon to refurbish the town hall's ramp, decking, and doors (as stated above), with payment to be made within specified time limit at a cost of \$1320.00 was made by Dale Zawislan, seconded by Dennis Brunner, motion carried. Furnace and thermostat update—shelved due to Carey's absence. Maintenance was done on the hall's furnace recently and it was decided that we would delay purchasing a new furnace at this time. Air filters will be checked by one of the Supervisors. Bug control will be out tomorrow to spray the hall and sheds. Equipment Responsibility—put away properly with shed doors closed and locked.

Old Business—Backdoor roof overhang-discussion on how to and what is really needed, Mark will look into this further.
