Town Board Meeting Minutes
(Unofficial)
November 11, 2025

The regular Town Board Meeting convened at 6:30 p.m. following the Budget Public Hearing and the Special Town Electors Meeting.

First order of business was to sign the check for Theresa Pankratz, Pankratz Excavating for gravel purchased this past month. Theresa left after thanking the town for our business. We also listened to Elizabeth Gebert—candidate for Wood County Circuit Court, Branch 3. She introduced herself and gave a brief declaration about her candidacy for Judge of the Circuit Court. She has 16 years' experience as a prosecutor, has been a past District Attorney, and is an advocate for victims. She excused herself after her talk.

Minutes of the October 14th Town Board Meeting were read by Jean. Dennis reported that he had attended the Wood County Emergency Management meeting on October 17th so that our township would remain eligible for FEMA funds in case of a disaster.

Motion to accept the minutes of the October meeting as read was made by Dale Zawislan, seconded by Dennis Brunner, motion carried.

Clerk reported that we received documents from First State Bank concerning the Retirement of our Loan for the grader. Mark noted that he received Second Notice of Non-Compliance of Full value assessment. This means our town is due for another reassessment in the upcoming years.

Treasurer's Report was given by Carey Rucker, motion to file report was made by Dennis Brunner, seconded by Dale Zawislan, motion carried.

Public Input—a guest was present to express concern about garbage pick-up complaint. She contracts with Waste Management individually to have garbage pick-up at a residence who also has township pick-up. We appreciated her input on this issue. A community member discussed paving Cary Rock Road. He also expressed concern about a missing road sign that caused people to be unaware that the road T'd and did not continue straight at the end of Falcon Road, causing someone to end up in his woods on the other side of Cary Rock Road.

New Business—Christmas Party to be held on December 9th following the December meeting. Garbage concerns need to be passed along to Carey also, due to taxing matters. Building Repairs—Lights not working at the main entrance.

Old Business—Motion to Adopt Final 2026 Budget was made by Dennis Brunner, seconded by Dale Zawislan, motion carried. Town of Cary was awarded a grant to Chip Seal Steffek Road for the amount of \$22,974.22.

Road Report—Lindsey Road got 50 loads of granite ½ mile N. of Baltus to ½ mile N. of Steffek; there is 1 more mile to complete the entire road. Road Inspection will not be done this fall. Equipment needs—we had to rebuild the mower head, will have to budget for replacement head in the next budget cycle, probably about \$20,000.

Next month's meeting will be on December 9th, 2025 at 6:00 p.m. with Community Christmas Party to follow.

Motion to adjourn was made by Dale Zawislan, seconded by Dennis Brunner, motion carried, adjourned at 7:55p.m.
